#### **Tools For Assessing Lake Health**

The attraction of living at the lake continues to grow exponentially in Minnesota. Lake living offers families opportunities to enjoy recreation, escape from the routine of modern life and to nurture family unity and fellowship. Investment in this life style is becoming more and more important to preserve and protect. There is high interest in pursuing information and education offered by government agencies and

academia to assist in taking advantage of this effort. Recent offerings by the Minnesota Department of Natural Resources (MN DNR), The Environmental Protection Agency (EPA) and the University of Minnesota (UMN) provide multiple programs to explore the challenges to lakes and opportunities to preserve and protect them.



#### **DNR Watershed Health Assessment Framework**

The <u>Minnesota Department of Natural Resources (MN DNR</u>) has recently announced the creation of a new online tool that provides access to water quality and health information for thousands of Minnesota lakes. The new tool, <u>Watershed</u> <u>Health Assessment Framework</u>, <u>(WHAF for lakes</u>), is easily accessed and navigated to give comprehensive information on virtually any Minnesota lake.

#### **EPA How's My Waterway**

An updated version of the <u>How's My Waterway</u> (HMW) application, developed by the Environmental Protection Agency (EPA), was released in June 2020. HMW provides a comprehensive overview of water quality data and information in the United States on three different scales: community, state, and national. Collecting data from eight databases across EPA, HMW answers questions about aquatic life, eating fish, swimming, drinking water, restoration, and protection. This tool can help users:

- Explore information about their drinking water, local stream conditions, and whether their waterways are suitable for swimming or eating fish and if they support aquatic life.
- Discover if their waterways are being monitored and the location of local monitoring stations.
- Learn what issues might be affecting their waterways.

## **University of Minnesota Lake Browser**

The <u>Lake Browser</u> has provided satellite derived water clarity, an indicator of lake water quality, data for over 10,000 Minnesota lakes since 2002. It has been updated with data created using an automated image processing system developed with resources from the University of Minnesota and the Environment and Natural Resources Trust Fund — Legislative and Citizens Commission on Minnesota Resources. The automated system processes all available satellite data (Landsat 8 and Sentinel 2) and provides daily (when clear imagery is available) and monthly (May – October) median clarity, chlorophyll and CDOM data for 2017 through 2021. Also improved are its capabilities for image and data display, geospatial analysis, and data access and download.
